TOWN OF SOMERS BOARD OF FINANCE REGULAR MEETING MINUTES October 25, 2022

1. Call to Order

2. Members Present

3. BOE Update

Superintendent Gagliarducci updated the Board on the current budget status and the current bond status. Superintendent Gagliarducci said the HVAC project is running behind because the contract negotiations held it up, but they have begun the design study. He also asked to Board for budget guidance for the FY2024 budget and what they think is a responsible budget increase.

4. Selectmen's Update

First Selectman Keeney updated the Board on the status of the Community Center project. There were over 700 responses to the survey that was mailed out to all households. The data is being compiled and the committee will meet to review it. Keeney also stated that a new developer has entered the field for the mill site and he has a meeting later in the week with the to look at the site.

5. CFO/Finance Department Update

Brian Wissinger reviewed the Finance Department Quarterly Report with the Board. At this time, no State Aid has been received, however, all ARPA dollars have been received. Also, Wissinger reported on his vision for future collections of revenue for the entire Town and the progress that has been made by the internal committee to review and develop a plan.

7. Appropriations – Stafford Medic

Brian Wissinger presented the breakdown of the appropriation for the costs associated with hiring another paramedic to service the Town of Stafford. A lengthy discussion followed.

Ralph Williams made a motion to table the appropriation until the Board has received sufficient data to determine the current costs and the proposed costs, seconded by Bruce Devlin. There was no further discussion and a unanimous decision followed.
