#### A.) CALL TO ORDER: First Selectman Tim Keeney called the meeting to order at 6:00pm.

- Roll Call First Selectman Tim Keeney, Selectmen Bill Meier and Bob Schmidt, CFO Michael Marinaccio, Assistant Finance Director Brian Wissinger, Police Administrator Kim Littig, Public Works Director Todd Rolland, Youth and Social Services Director Allison Maynard and Fire Chief John Roache.

#### C.) PRESENTATIONS BY THE FIRST SELECTMAN –

Mr. Keeney announced upcoming community events

#### D.) CONSENT AGENDA

Boards and Commissions: Appointments/Resignations
 Economic Development Commission- Appointment of Ann Levesque to the Economic Development Commission with a term expiring on 12.22.27

Mr. Schmidt made a motion to appoint Ann Levesque to the Economic Development Commission with a term expiring on 12.22.27, seconded by Mr. Keeney. The motion unanimously passed.

#### E.) OPPORTUNITY TO ADD URGENT AGENDA ITEMS:

Mr. Keeney made a motion to add an agenda item, Salary adjustment Recommendation for Lisa Madden, Tax Collector, seconded by Mr. Schmidt. The motion unanimously passed. A Discussion followed.

Mr. Marinaccio recommended effective July 1, 2022 Ms. Maddens salary be increased from \$68,959. To \$78,000., an increase of 13%. Which included a 5% increase withing the 4% approved 2021-22 pay pool. The funding for the increase is already available in the FY2023 adopted budget and would not require an additional appropriation. Marinaccio stated Ms. Madden is highly qualified and recognized as a leader in her profession and possesses outstanding credentials.

Mr. Keeney made a motion to increase Lisa Madden's Salary 7/1/22 from \$68,959. to \$78,000., seconded by Mr. Schmidt. The motion unanimously passed.

#### H.) PENDING BUSINESS

Mr. Schmidt made a motion to hire Kathy Lamkin of HR2U, Inc. and authorize the First Selectmen Keeney to sign the Agreement with not to exceed \$15,000, seconded by Mr. Keeney. The motion unanimously passed.

- a) Discussion and Possible Action on Staffing Request for Summer Camp Social Worker Mr. Schmidt made a motion to approve the request to hire Kelli Martin as the Summer Camp Social Worker, seconded by Mr. Keeney. The motion unanimously passed.

     Officers (Per the Police Accountability Act)
     *Mr. Schmidt made a motion to approve the Drug Urinalysis Screening Program for the Somers Police Officers, seconded by Mr. Keeney. The motion unanimously passed.*
- c) Discussion and Possible Action to Authorize the First Selectman to sign the Agreement between the Town of Somers and North Central Conservation District. Mr. Schmidt made a motion to authorize First Selectman Keeney to sign the Agreement between the Town of Somers and North Central Conservation District, seconded by Mr. Keeney. The motion unanimously passed.
- d) Discussion and Possible Action to Authorize the First Selectman to sign the Watchaug Road Culvert Project Contract.
  Mr. Schmidt made a motion to authorize First Selectman Keeney to sign the Watchaug Road Culvert Project Contract with Avery Construction, seconded by Mr. Keeney. The motion unanimously passed.
- e) Discussion and Possible Action to the Existing and New Complaints at Camp Aya-Po. The Board of Selectmen and Public Works Director Todd Rolland discussed the current issues at Camp Aya-Po such as dogs off leash, vandalism, trash dumping etc. A discussion followed. Mr. Rolland made a request to form an Ad-Hoc Committee to look at property and what the need is to put an end to some of the issues the Town is having.

  Mr. Schmidt Made a motion to form an Ad-Hoc Camp Aya-Po Advisory Committee and have Mr. Rolland come back to the Board with recommendations on the members and charges for the committee, seconded by Mr. Keeney. The motion Unanimously passed.

The Board of Selectmen of Somers and Stafford will plan to meet for a joint meeting later this month to discuss Regionalization of EMS Services.
