### A.) CALL TO ORDER: First Selectman Tim Keeney called the meeting to order at 6:00pm.

Mr. Schmidt made a motion to hire Kevin Wood for the 12-month grant funded full time Recreation Coordinator at \$40,000., seconded by Mr. Meier. The motion unanimously passed.

 Mr. Meier made a motion to approve the WPCA staffing recommendation to hire Adam Bajoris as the Part time 10 hours a week WPCF Maintainer position at \$23.25/Hr, seconded by Mr. Schmidt. The motion unanimously passed.

- c) Discussion and Possible Action on Trespass Ordinance The Board of Selectmen held a public hearing on July 21, 2022 at 7:00pm to take public comment on the Trespass Ordinance Mr. Schmidt made a motion to adopt the Trespass Ordinance to be effective 15 days after publication, the publication will be in summary form, Seconded by Mr. Meier. The motion unanimously passed.
