## PUBLIC HEARING:

Application #24-002: Somers Mountain Properties, LLC, 359 Mountain Road, Somers; seeking a Text Amendment to section 214-6.11 and 6.12 of the Somers Zoning Regulations, as they relate to Farm Wineries.

Shane Manning made a motion to open the public hearing, Dan Fraro seconded, all in favor, motion carried.

Jennifer Roy confirmed for the record that legal notice was published in the Journal Inquirer April 27 and May 3, 2024; and the application was filed with the Town Clerk May 2, 2024. Ms. Roy referenced positive referrals back from the Planning Commission and CRCOG. Also, Ms. Roy provided her staff review/memo with a few suggested changes to the text (Exhibit 1). Copies provided to the commission members and applicant.

Attorney Dory Famiglietti and Mark Murdoch addressed the commission regarding the proposed text amendment. Attorney Famiglietti provided documents giving a history of Worthington Winery and how they came to this application for text amendment to section 6.12 of the regulations regarding farm wineries. Attorney Famiglietti also provided copies of the Special Use permits for 359 Mountain Road, Worthington Pond and Worthington Winery (Exhibit 3).

A lengthy discussion was held, going over each section of the proposed text.

Shane Manning made a motion to continue the public hearing to June 3, 2024 at 6:30pm. Howie Coro seconded the motion, all in favor, motion carried.
