**Senior Center Update:**

Lunches are now being held inside the Senior Center, they may be capped at a certain number of people. Outside tables are being implemented, one month at a time is the plan.

Senior Center Personnel updates: Interviews will begin for hiring a staff member for the Senior Center, it will be at least another month before the position is filled.

The Senior Center is in the process of getting approved for a renovation for a more private office for Flo and Pam. There are also renovation ideas being discussed for Kibbe Fuller to accommodate the activities being held.
