Call to Order: First Selectman Bud Knorr called the meeting to order at 4:00pm.

Members Present: First Selectman Bud Knorr, Selectmen Kathy Devlin and Tim Potrikus. CFO Michael Marinaccio, Assistant Financial Director Brian Wissinger ZEO Jennifer Roy, DPW Director Todd Rolland and Chief John Roache, Trooper Michael Hevey, also in attendance many concerned citizens.

Pledge of Allegiance: All Members participated in the Pledge of Allegiance.

Mass Gatherings Ordinance Discussion:

The Board of Selectmen heard the concerns of the affected residents who host large gatherings/events. A lengthy discussion followed:

Mr. Potrikus made a motion to refer back to committee to revise for three points: 1. add in an Agricultural Fair Exemption to reflect State statue.

- 2. Also modify that non-agricultural applicants can provide the Town with a 'seasonal calendar' to supplant the need for several permits; with the condition that any significant event that should be scheduled after the submission of a seasonal calendar would then necessitate its own permit.
- 3. Add a condition that Permit requests made within 60 days of the event date may result in notice to the applicant that the application may only be permitted provided the town can provide adequate coverage. Seconded by Mrs. Devlin. The motion passed

Charter Revision Resolution and Appointments:

Ann Logan Town Clerk joined the meeting at 5:15pm to review the timeline for the Charter Revision and present the Resolution for approval.

Mr. Potrikus made a motion to approve the Resolution regarding the charter revision (see attached), seconded by Mrs. Delvin. The motion passed

2018/2019 Budget Approval:

Made a motion to approve fiscal year 2018/2019 budget in the amount of \$7,469,645.00 with a - 3.70% reduction from Fiscal year 17/18, seconded by Mr. Potrikus. The motion passed

PD Fees for Outside Services:

Ms. Littig is recommending the fees be increased for assigning a Trooper to outside service to \$120 for to cover the costs associated with assigning a Trooper. Town officer fees for outside services will remain at \$75 an hour.

Mr. Potrikus made a motion to approve the recommendation to adjust the Trooper fees to \$120 an hour, seconded by Mrs. Devlin. The motion passed.

Authorization of Scheduled Payments:

Mrs. Devlin made a motion to approve the authorization of scheduled payments in the amount of \$200,839.82, seconded by Mr. Potrikus. The motion passed.

Adjournment:

Mrs. Devlin made a motion to adjourn the meeting at 5:45pm seconded by Mr. Knorr. The motion passed.

Whereas, pursuant to Section 7-190(b) of the Connecticut General Statutes, the Board of Selectmen of the Town of Somers, desires to make recommendations to the Charter Revision Commission; and

Whereas, pursuant to Section 7-190(b) of the Connecticut General Statutes, the Board of Selectmen of the Town of Somers must establish when said Commission shall submit its draft report to the Clerk of the Town of Somers for transmittal to the Board of Selectmen.

Now, Therefore, be it resolved by the Board of Selectmen of the Town of Somers that the following recommendations be directed to the Charter Revision Commission forthwith:

- Shall the role of the Town Clerk become an appointive rather than elective position;
- Shall the town remain guided by an elected Board of Selectmen, or should we move to a Town Manager form of government;
- Shall the Zoning and Planning boards be combined into one appointed/elective body;
- Shall the number of members on the Zoning Commission be revised
