***Mr. Schmidt questioned whether or not the School had a Medical Advisor. A lengthy discussion followed. The Board of Selectmen will extend and invite to Mr. Luigi Sartori the Town Director of Health to attend a future Selectmen's meeting for a Public Health presentation.***
