## 1. Call to Order.

**a.** Meeting called to order at approximately 8:00 pm by Chairman Tim Potrikus.

- 5. Discuss issues or concerns raised during Public Hearing of February 17, 2015 concerning the Fire Commission Ordinance.
  - **a.** It was discussed and determined that there were no major concerns or objections raised during the hearing on the Fire Commission Ordinance.

## 6. Discuss Deleting Section 5-10 Board of Fire Commissioners, from the Charter.

- **a.** The timing of the adoption of the new ordinance, the agreement between the town and the volunteers and the potential removal of section 5-10 from the charter was discussed. Specifically, whether a certain order of passage should be considered to assure that the town is not without a Fire Chief at any time. It was determined that the Fire Commission Ordinance, if adopted, properly addresses the concern whether or not section 5-10 is removed from the Charter through the revision process.
- **b.** It was discussed whether removal of section 5-10 was proper and if a procedural mechanism would exist to assure the town has a Fire Chief if the section was removed. It was decided that the Fire Commission Ordinance was a proper solution.
- **c.** Motion by B. Pellissier moved to table further discussion until after a March 3, 2015 hearing, seconded by T. Potrikus- voted unanimously in favor.

- **a.** The Charter Revision Commission will hold a public hearing at 7:00 p.m. on March 3, 2015 at the Somers Town Hall to discuss the possible removal of Section 5-10, Board of Fire Commissioners, from the Charter.
