Meeting Minutes of 9/10/2018

- 1. Call to Order: Mr. Cheney called the meeting to order at 7:05. EDC members present: Rick Cheney, Vicki Clark, Sarah Maskill, and David Marti. Community members present: Budd Knorr and Fatima Shahan.
- 2. Minutes: Mr. Marti made a motion to accept the meeting minutes of the 6/4/18 meeting. Ms. Clark seconded the motion and te motion passed 5-0.
- 3. Welcome New Members: No new members.
- 4. Correspondence: Ms. Clark reports correspondence via FB regarding the directory.
- 5. Old Business
 - a. Directory App/Town Website Training: Mr. Cheney will speak with Mr. Potrikus to explore the terms of the Directory app.
 - EDC Business Cards Proposal/Pricing: Ms. Clark will provide social media handles to Mr. Marti.

 - e. Strategic Town Development
 - i. Mill Site: Mr. Knorr reports \$2.2 million spent on the remediation of the mill site. All funds have come though grants. An outstanding cost of \$735,000 is needed to rebuild the walls, and \$200,000 for the Maple Street bridge reconstruction. Grant funding is in process. An RFQ has been developed and will be released within the next two weeks. Mr. Knorr also discussed the implementation of the 2015 POCD, and is working with Planometrics to update zoning and related ordinances. He also discussed the expansion of a natural gas line into Somers. Mr. Knorr left the meeting at 8:16.
 - f. Business Questionnaire programing project: Mr. Ritacco is not present.
 - g. Communication Seminar Project: Ms. Clark continues to work toward a seminar for local businesses.
