b. Zoning Referral: #19-005: Grower Direct Farms, 143 Four Bridges Road, Somers, CT, application for a Special Use Permit for Greenhouse operation, in the A-1 Residential Zone, per section 214-88B(30) of the Zoning Regulations.

Adam Van Wingerden recused himself from this application discussion.

Sam Smyth and Jay Ussery described the proposal to install six greenhouses and grow mums on a 75 acre parcel located at 143 Four Bridges Road.

William Salka made a motion to send the Zoning Application #19-005: Grower Direct Farms, 143 Four Bridges Road, Somers, CT, application for a Special Use Permit for Greenhouse operation, in the A-1 Residential Zone, per section 214-88B(30) of the Zoning Regulations back to the Zonng Commission with a favorable recommendation. The motion was seconded by James MacFeat. A vote was taken and all were in favor, the motion passed.
