1. Field #5 (50d70qfield):

- a. Excavation / grading is complete,

  - c. All irrigation repairs are complete and the new field is full irrigated,
  - d. If the weather cooperates we will install the infield and bases this month, if not it will be in the spring
2. T-ball field behind Town Hall:
- a. Excavation / grading is complete,
  - b. Loaming & seeding is complete,
  - c. Hay has been placed (no irrigation),
3. Intersection improvements Ninth District Road / Main Street:
- a. Most construction is delayed until spring of 2014;
  - b. CL&P has completed moving of the power lines, communication companies must now move their lines before drainage and infrastructure improvements can begin;
  - c. There may be some roadwork this fall;
  - d. Ninth DST Road closure is scheduled for July & August of 2014.
