a. Somers Softball Requests – Cindy represented Softball

- Scoreboard have been installed on Fields 2 & 3 by the Softball Association

Motion – “The Recreation Board of Directors recommends allowing the Softball Association to put up signs thanking the sponsors who generously contributed to purchase & install the scoreboards on fields 2 & 3”.

DPW will do the work but how this will be paid for is still to be determined. Field 1 still needs to be done. It could also be done this year but will not cost as much as the repairs that need to be done on Field 3.
