TOWN OF SOMER WATER POLLUTION CONTROL AUTHORITY REGULAR MEETING MINUTES April 6, 2016 7:15 PM -TOWN HALL

I. CALL TO ORDER

The meeting was called to order at 7:20 pm by Chairman, James Botellio. Other members present were: Charles Colby, George VanTasel, Mark Marschall and Steve Getman,(7:30). Also present was Steven Jacobs, Town Sanitarian.

II. PUBLIC HEARING: Somersville and Maple Ridge Sewer 2016-17 O&M Budgets

Mr. Botellio read the notice for the hearing. Mr. Jacobs told the Authority that he did get the bank statement from The Finance Dept. and the numbers appear to balance with the current billing system. There was no other questions and no audience present.

A motion was made to close the hearing at 7:23 pm by Mr. Colby. 2nd by Mr. Marschall, all in favor, motion passed.

III. MINUTES APPROVAL

The minutes of March 1, 2016 were reviewed.

A motion was made to approve the minutes as written by Mr. VanTasel. 2nd by Mr. Colby, all in favor, motion passed.

III Hall Hill Rd. – Sewer Main Extension

Mr. Jacobs said he met with Ms. Conners to inspect the plumbing in her houses and the plans are being finalize. Do to the small size of the project, he recommended we forgo a formal bid and put it out to local contractors, as they would likely be the most competitive. So long as we obtain at least 3 bidders, we will comply with the Finance Depts. requirements. The next step would be to hold a public hearing on the expansion of the sewer service area.

A motion was made to hold the public hearing on May 3, 2016 at 7:15 pm by Mr. Colby. 2nd by Mr. Getman, all in favor, motion passed.

IV Somersville & Maple Ridge 2016-17 O&M Budgets

- A motion was made to approve the Somersville WPCF 2016-17 budget of \$88,610.00 with a User Rate of \$255.00/EDU by Mr. Colby. 2nd by Mr. Getman, three in favor, Mr. Botellio and Mr. Getman abstained, motion passed.
- A motion was made to approve the Maple Ridge Comm. System 2016-17 budget of

\$8,150.00 with a User Rate of \$145.00/EDU by Mr. Getman. 2nd by Mr. Marschall, all in favor, motion passed.

IV. CORRESPNDENCE/AUDIENCE PARTICIPATION

Mr. Jacobs told the Authority that the new sewer billing system by QDS has been loaded on
to the town server but he has not yet gotten a password nor opportunity to review it. The
Authority is concerned that there has been no demonstration of the product prior to purchase
and communication has been minimal. Mr. Botellio would like to meet with QDS, Mr.
Jacobs and the Finance/Tax Depts. to have them go over the system and show it's
capabilities.
