**I. CALL TO ORDER**

Bids are due back on July 12<sup>th</sup> and Ms. Connors will be invited to the August meeting to discuss the costs.

There is approximately \$48,000 in deferred assessments yet to be collected. The Authority would like time to decide what to do with these funds and will consult with the Town Attorney and Finance Director.
- Progress on the new billing system by QDS has been slow. The Authority suggested cc'ing Lisa Pellegrini with all correspondence so she is aware of the situation.
