TOWN OF SOMERS WATER POLLUTION CONTROL AUTHORITY REGULAR MEETING MINUTES December 5, 2017 7:30 PM -TOWN HALL

I. CALL TO ORDER

The meeting was called to order at 7:30 pm by Chairman, James Botellio. Other members present were: Stephen Getman, Daniel Fraro, Charles Colby, and Mark Marschall. Also present was Steven Jacobs, Town Sanitarian.

II. MINUTES APPROVAL

III. Conn. Dept. of Public Health – Local Health Assessment

Mr. Jacobs reported that the town received the Assessment Report from the CT-DPH. The report cited many more shortcomings then were expressed at the meeting. A draft response to the state was discussed and will be finalized when Selectman Devlin has had a chance to review.

IV. 111 Maple Ridge Dr. – Tank Replacement

Mr. Jacobs reported that Atty. Landolina confirmed that the homeowners are responsible for tank replacement cost on the Maple Ridge system. Parker Septic Service was the lower bidder. A letter will be sent to the owner informing them of the cost and giving them the option of hiring their own licensed contractor.

V. CORRESPONDENCE/AUDIENCE PARTICIPATION

- A letter was sent the owner of 8 Shaker Rd. informing him that the sewer user fee will remain 2 EDU's unless the use of the property use is legally changed.
- Mr. Jacobs reported that the finance dept. is going to transfer the \$300K from the sewer fund to the General fund to cover the years those transfers were not made. There is currently \$625K in our account. An updated report will be given t the Authority.
- Mr. Jacobs reported that many of the town boards are now starting their meetings at 6:30

pm. The consensus was this would be more convenient, however the Authority would like input from the absent members prior to making a change.
