CALL TO ORDER. The Public Hearing was called to order at 7:00 pm by Chairman Stephen Getman. Also present were Daniel Parisi, WPCA Superintendent, Matt Jermine of Weston & Sampson and John Rozo of Weston & Sampson.

- II. WPCF PLANT UPGRADE: WESTON & SAMPSON. Matthew Jermine provided a favorable update on the completed work on August 5<sup>th</sup> at the WPCF. John Rozo spoke of the leak under the wall between pass 2 and the outlet, to stop the leak they are looking at injecting an expanding epoxy. They also talked about installing a filter before the UV Chamber to collect more of the solids. Mr. Jermine spoke of adding pea stone to the sand for better drainage. They also talked about upgrading the control system. Weston & Sampson are working on the draft plans for the next phase of the project.
- III. SOMERSVILLE WPCF: FACILITY UPGRADE PROJECT FUNDING: Daniel Parisi spoke that Congressmen Courtney's, they are waiting for the Federal Government to pass the Budget
