

TOWN OF SOMERS WATER POLLUTION CONTROL AUTHORITY REGULAR MEETING MINUTES November 1, 2022 7:00pm Regular Meeting and Zoom AMENDED

CALL TO ORDER. The Regular Meeting of the Somers WPCA was called to order at 7:00 pm by Chairman Stephen Getman. Other members present were: Emily Dreyer, Tim Vecchiarelli, Dan Fraro, Duane Mason and Mark Folsom. Also present were Daniel Parisi, WPCA Superintendent, Matt Jermine of Weston & Sampson. - I. MINUTES. The minutes of the Regular Meeting of October 4, 2022 were reviewed, with amendments. A motion was made by Emily Dreyer to approve the minutes, seconded by Mark Folsom, all in favor, motion passed.
- II. WPCF PLANT UPGRADE: WESTON & SAMPSON: Matt came to the plant on 10-31-2022 to see the contact chamber and the solids on top of the water. Matt spoke of a skimmer or pump to pump the solids back to the head of the plant. The solids were coming from the beds as they sluff off. Weston & Sampson is looking at scheduling the repair of the leak in the chamber now that the disinfection season is done. Weston & Sampson are working on the draft plans for the next phase of the upgrade.
- III. SOMERSVILLE WPCF: FACILITY UPGRADE PROJECT FUNDING: Daniel Parisi updated the Board that Congressmen Courtney's office is waiting for the Federal Government to pass the Budget
- IV. WPCA 2022-2023 BUDGET: Reporting and Balance, the Board commented, questioning some of the figures and that some re not needed.
