OLD BUSINESS:

Site plan application #18-002: Steve Riley, 21 Eleanor Road, Somers

Suzanne Choate, Design Professionals, Inc. presented a brief update on the site plan to construct "self-storage" facility at 21 Eleanor Road. Ms. Choate mentioned the requested changes from the Sanitarian have been incorporated.

Jill Conklin pointed out that they should be sure that the property is situated on several acres, so as to not be in close proximity to the neighboring homes. Discussion followed, suggesting various locations throughout town. Ms. Bowers thanked the commission for their time.
