CALL TO ORDER at 6:42pm Members present: Jill Conklin, Dan Fraro, and Karl Walton-via telephone. Absent: Paige Rasid and Lucas Cherry Also present Jennifer Roy, Staff Liaison.

Public Heairng:

1. #21-003: Driving Range 349 Main Street LLC, Sonny's Place, 349 Main Street application for a modification of existing Special Use permit to include a new 18-hole miniature golf course and bumper boats pursuant to Section 3.2E(2) of the Somers Zoning Regulations, in the A1 zone.

Tim Coon of JR Russo & Associates present to discuss proposed expansion at Sonny's Place. They are proposing adding a second mini-golf course, as well as bumper boats. This is a 21.6-acre parcel, they are proposing moving climbing wall and monkey motion; adding mini-golf and bumper boats. The applicant will also reconstruct and improve drainage on the westerly portion of the parcel. Additional seating, viewing area and parking will be added. Total parking spaces will be 318 which will include the required handicap spaces.

Discussion was held, and proposed site plan reviewed.

Jennifer Roy commented Jeff Bord has given approval of revised plans dated November 11, 2021, as well as Steve Jacobs, Sanitarian. Ms. Roy noted that she was awaiting written approval from Sanitarian.
