Mr. Shapiro recused himself from the participating the public hearing/decision for the regulations.

Glenn Chalder of Planimetrics gave a brief presentation on the proposed draft regulations.

The floor was opened for public comments:

Mark Murdoch, 24 Gulf Rd, Somers – spoke suggesting changes to the Farm Winery section. Sean Clark, Attorney for the Murdoch's – spoke suggesting changes to the Farm Winery section, as well as several other parts of the regulations.

Ken Prior, 364 Mountain Rd, Somers – spoke in opposition of certain sections within the regulations; concerns pertaining to Farm Winery/Farm Brewery/Farm Distillery & function rooms being permitted in a residential zone.

Ken Coelho, 605 Stafford Rd, Somers – is in favor of the proposed regulations but has concerns about the Farm Winery regulation.

Eleanor Lebine, 9 Mountain Rd, Somers - spoke in opposition

Caroline Skowronek, 36 Grist Mill Terrace, Somers - spoke in favor

Paul and Donna Milliken, 99 Parker Rd, Somers - spoke in favor

George Schober, 98 Rocky Dundee, Somers – spoke in opposition of several sections of the proposed regulations; including but not limited to commercial kennels in residential zones, and winery/brewery/distilleries in residential zones.

Ryan Stager, 372 Mountain Rd, Somers – opposed to functions rooms and food trucks

Brad Gawron, 30 Haas Rd, Somers – spoke in opposition to several items

Kevin Riley, 17 Ninth District Rd, Somers –spoke in favor

George Schober, 98 Rocky Dundee, Somers – spoke in opposition of retail sales at wineries Karen Murdoch, 32 Gulf Rd, Somers – spoke about wineries and concerns regarding same

Dominic Wilson, 50 Mulberry Ln, Somers – expressed concerns the farm winery regulation is ambiguous.

Monique Andrade, 204 Turnpike Rd, Somers – spoke in favor

Darryl Lecours, 21 Long Hill Dr, Somers - spoke in favor

Michelle Prior, 364 Mountain Rd, Somers – spoke in opposition

Tim Percoski, 55 Manse Hill Rd, Somers – spoke in favor

Bob Garlick, 52 Juniper Hill, Somers – spoke in favor, but expressed a few concerns
