I. CALL TO ORDER at 6:00pm Members present: Jill Conklin, Karl Walton, Dan Fraro and Paige Rasid. Absent: Lucas Cherry and Bill Shapiro Also present Jennifer Roy, Staff Liaison and Carl Landolina, Town Attorney

II. PUBLIC HEARING:

1. #21-002: Mark and Karen Murdoch, 359 Mountain Road, Somers; seeking a Special Use Permit for a Farm Vineyard and Winery pursuant to Section 6.12 of the Somers Zoning Regulations to allow the operation of a tasting room and sale of wine for consumption on and off premises.

Jill Conklin read the legal notice and opened the public hearing at 6:20pm.

III. DISCUSSION/POSSIBLE DECSION:

1. #21-002: Mark and Karen Murdoch, 359 Mountain Road, Somers; seeking a Special Use Permit for a Farm Vineyard and Winery pursuant to Section 6.12 of the Somers Zoning Regulations to allow the operation of a tasting room and sale of wine for consumption on and off premises.

Mark Murdoch gave a presentation to the commission. Explained current site plan and application, as well as future vision for the Farm Winery. The initial plan will be to use existing structures; the warming house for tastings and the sugar shack for manufacturing the wine. There is a proposed tent near the covered bridge, for use as weather permits.

Discussion was held. Attorney Landolina asked Mr. Murdoch several questions regarding the metering of sound as well as status of current Special Use permit for the property. Mr. Murdoch is responded; not testifying as an expert on the sound; and that they are not currently intending on abandoning their current Special Use permit.
