GENERAL SPECIFICATION:

1. It is the intent of the Town of Somers to process approximately 15,800 cubic yards of green waste materials, at two locations, inclusive of branches, logs, and stumps, to a maximum size of approximately 2-inches. It is the responsibility of the processor to provide adequate equipment necessary to feed materials to the processing equipment from the stockpile of raw material. Processed material shall be stockpiled on-site as specified by the Town.
2. Work hours are to be Monday through Friday 7:00 A.M. - 3:30 P.M. No work will be done during regular scheduled holidays, weekends, and unforeseen closures.
3. Material is located in three piles, two at the Town of Somers Field Road Park (96Field Road, Somers, CT), and one at the Town of Somers Transfer Station (127 Egypt Road, Somers, CT). The piles are of the following approximate sizes:
 - The front pile at the Park, 5,200 cubic yards
 - The rear pile at the Park, 8,000 cubic yards
 - The pile at the Transfer Station, 2,600 cubic yardsShould a vendor wish to view the debris before submitting a bid, the vendor must contact the Public Works Office at (860) 763-8238 to schedule a viewing time. Appointments will be scheduled on a first-come, first-serve basis during regular workdays from 7:30 A.M. - 3:00 P.M.
4. All vendors must provide proof of insurance for all vehicles and employees while working on Town property. A certificate of insurance must be submitted by the awarded vendor to the Town of Somers Finance Department (600 Main Street, Somers, CT 06071) before the start of work. This certificate of insurance must name the Town of Somers as an additional insured.
5. The Town of Somers expects all vendors to be familiar with all OSHA Safety Rules, Regulations, and Guidelines and adhere to all of these.
