Town Meeting Minutes December 21, 2010

The Town meeting was called to order by First Selectwoman Lisa Pellegrini at 7:31 pm with approximately 23 individuals in attendance. Ms. Pellegrini requested that the legal notice for the meeting be read aloud by Town Clerk Ann Marie Logan.

Elect a Moderator

A motion was made by K.Devlin, seconded by C.Pyne to nominate Lisa Pellegrini at moderator. No other nominations presented. Motion was made, seconded and unanimously voted to close nominations. Motion on floor that Lisa Pellegrini be elected moderator - All in Favor - Unanimous

Confirmation of certain Board/Commission Appointments

Motion was made by J.Tolisano, seconded by K.Devlin that the appointees be voted upon as a group rather than individually. No Discussion - Motion was made, seconded and unanimously voted to confirm the following Board of Selectmen appointments:

Approve the transfer of two parcels of land for no consideration from the Town of Somers to Dan Roulier &

Attorney Landolino explained that the two parcels of land are within a former Right of Way into a now established subdivision developed by Mr. Dan Roulier. Once transferred to Mr. Mr. Roulier, the small triangular pieces will be transferred to the abutting property owners. A motion was made by J.Tolisano, seconded by D.Pinney and unanimously voted to authorize the First Selectman to sign the deeds transferring the land to Mr. Roulier

Approve the discontinuance of a public right of way over property shown as 'For Future Road' approximately 50' wide and located between 94 and 104 Rye Hill Circle.

Attorney Landolino explained that the ROW was established so that the Camerota Subdivision (abutting Rye Hill Circle) had the ability to connect with the Rye Hill Subdivision. Mr. Camerota has stated he has no intention of further developing his approved subdivision or any intention of connecting the two subdivisions through the ROW. The discontinuance of the ROW was recommended by the Planning Commission and the Board of Selectmen. The property would be divided equally between the abutting property owners. A motion was made by J.Tolisano, seconded by K.Devlin and unanimously voted to allow First Selectwoman Pellegrini to establish and sign a deed on behalf of the Town of Somers and convey the now discontinued ROW to the two abutting property owners at 94 and 104 Rye Hill Circle.

Motion was made by J.Tolisano, seconded by K.Devlin, and unanimously voted to adjourn the Special Town Meeting of December 21, 2010 at approximately 7:40 pm
